- This page informs you of our policies regarding the collection, use and disclosure of Personal Information when you use our Service.
- ASK Ventures is committed to ensuring that your privacy is protected. We will not use or share your information with anyone except as described in this Privacy Policy.
- We use your Personal Information for providing and improving the Service.
